**Purchases of tobacco, alcohol, and firearms are prohibited under the plan.

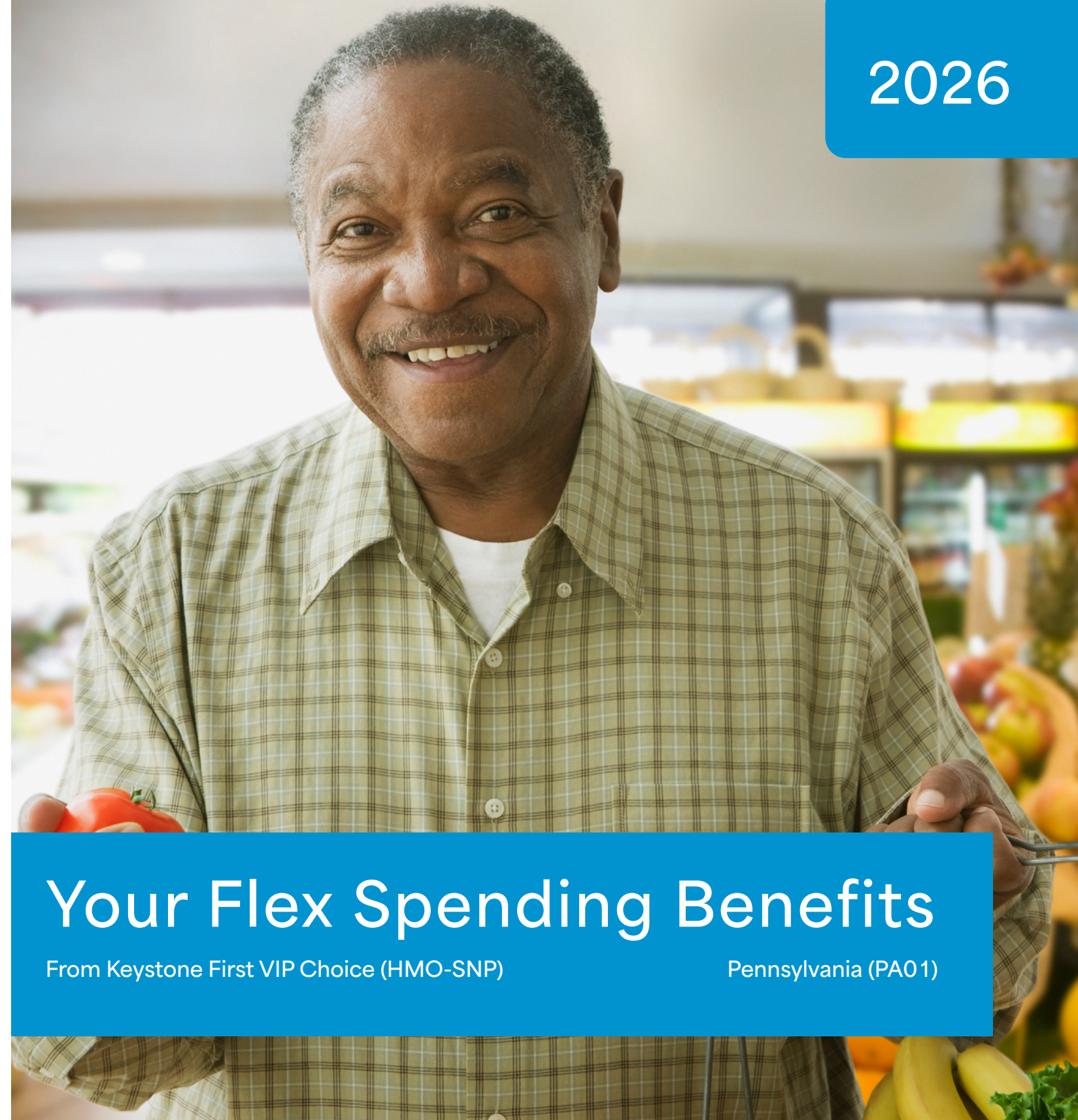

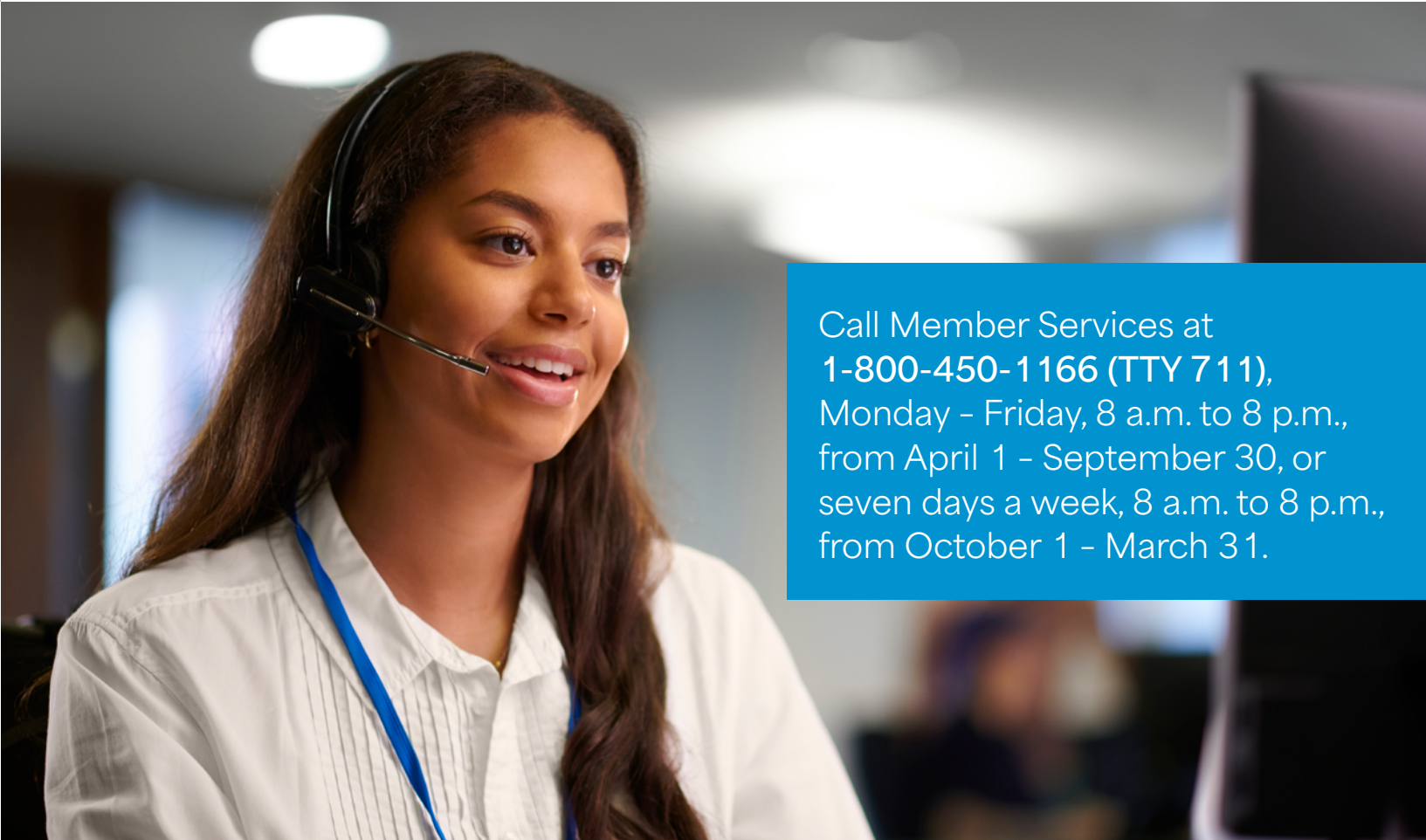
